

# COST OF SERVICE OPTIONS FOR UTILITIES

It includes an integrated rate design module to go straight from developing a revenue requirement in the COST<sup>™</sup> model to designing rates for that revenue requirement.

The COST<sup>™</sup> model has built-in validation and error checking, a data import tool to eliminate linked files to the model, and a scenario analyzer to quickly determine how various changes will affect the results of the model. In addition to addressing cost of service needs, the COST<sup>™</sup> model can also be used to help your organization design bnew innovative rate structures, splitting apart existing rate schedules or aligning rates for multiple jurisdictions. MCR's COST<sup>™</sup> model can be implemented in different ways to meet the requirements and budget of your organization.
